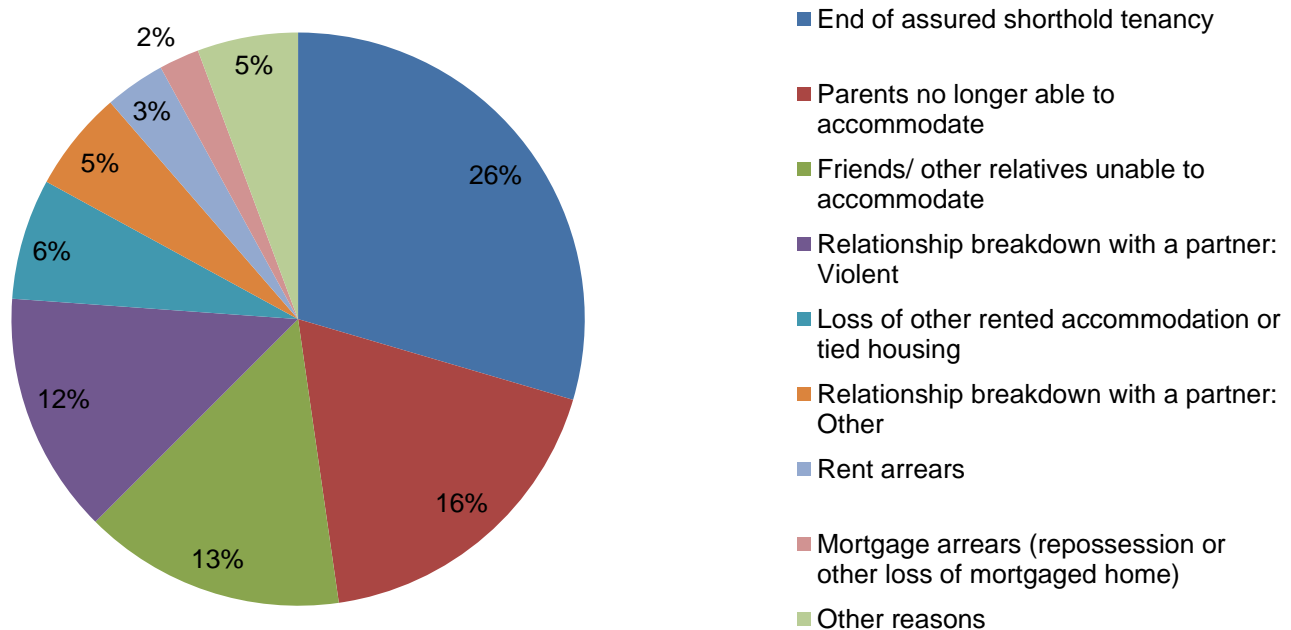

- In England, more than 86 880 households were found to be homeless during 2015/16.

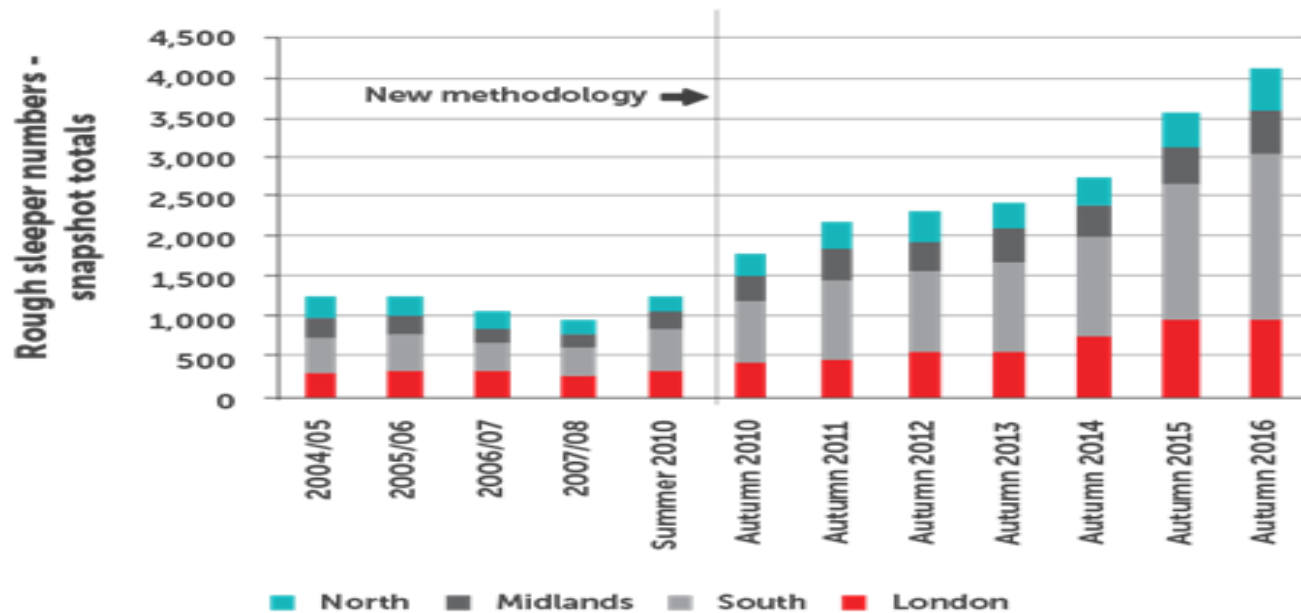
Main Reason For Homelessness

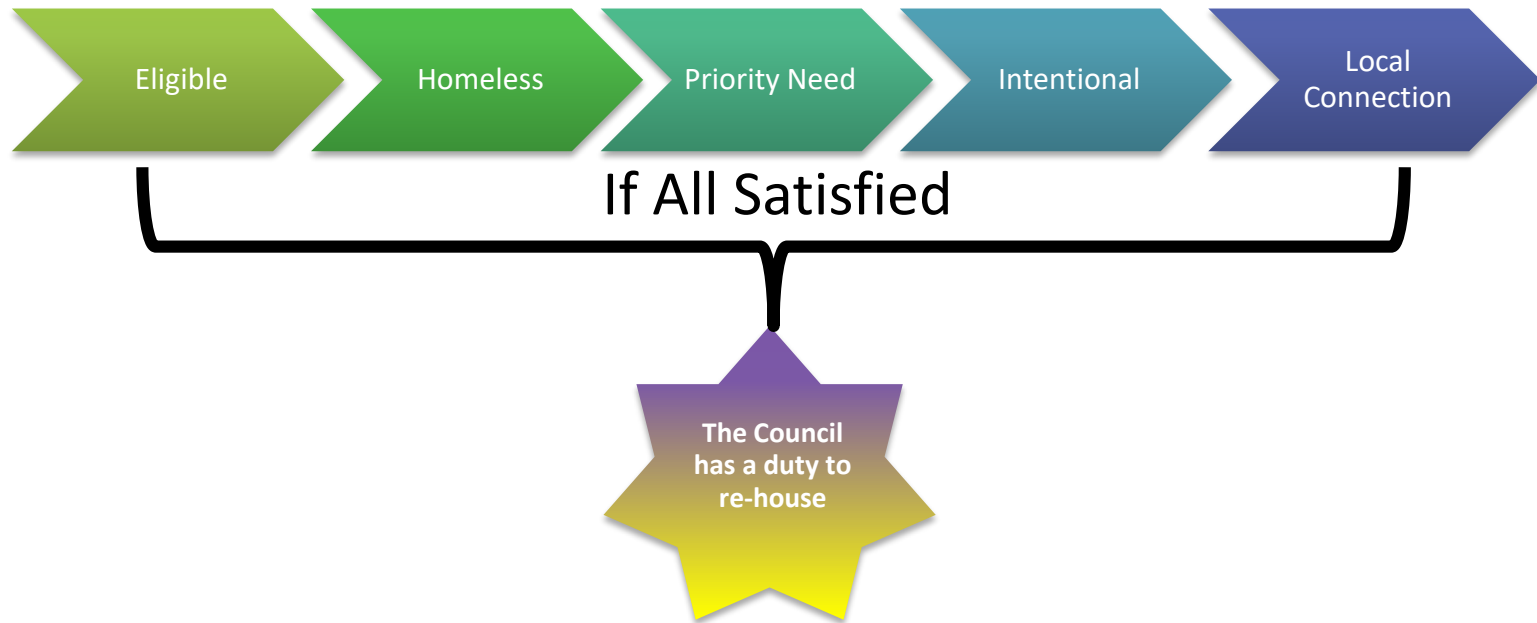
# National Homelessness.

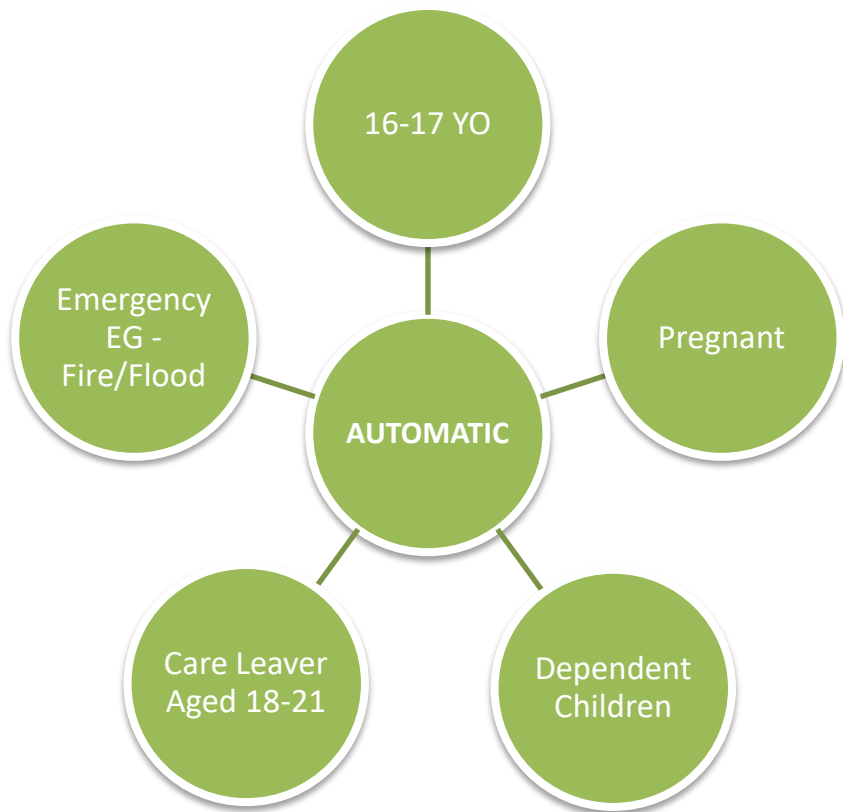

# Define Homelessness

- No accommodation available in this country or elsewhere
- Has accommodation but cannot secure entry
- Not suitable to continue to occupy property  
(e.g. Domestic Violence/ Property Condition)
- Home consists of a moveable structure (e.g. boats/caravan) but there is no place to dock/park

# 3. Priority Need



## 4. Intentionality

A **deliberate act** or **omission** that resulted in the loss of accommodation that was **reasonable** for the applicant to continue to occupy

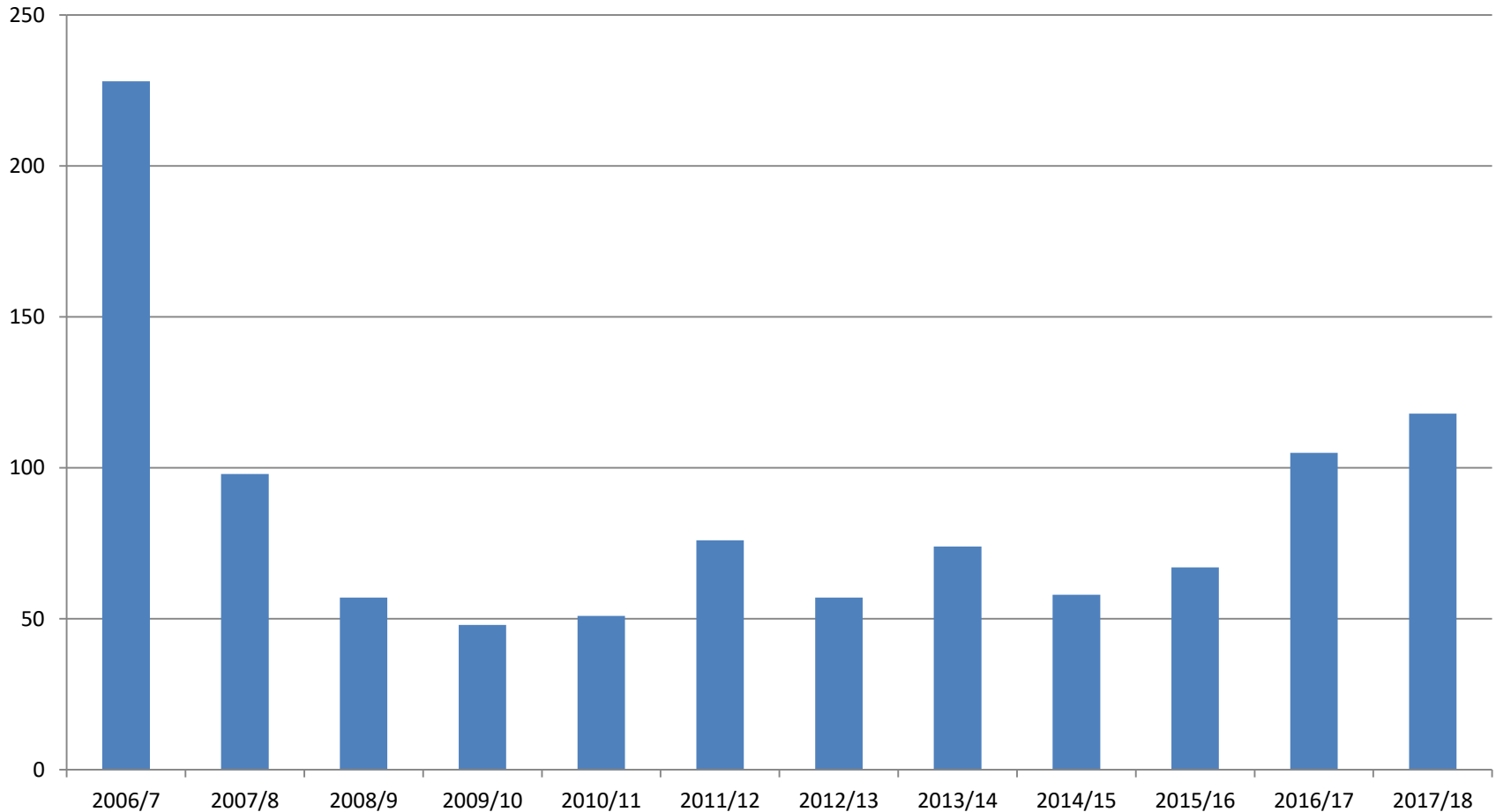

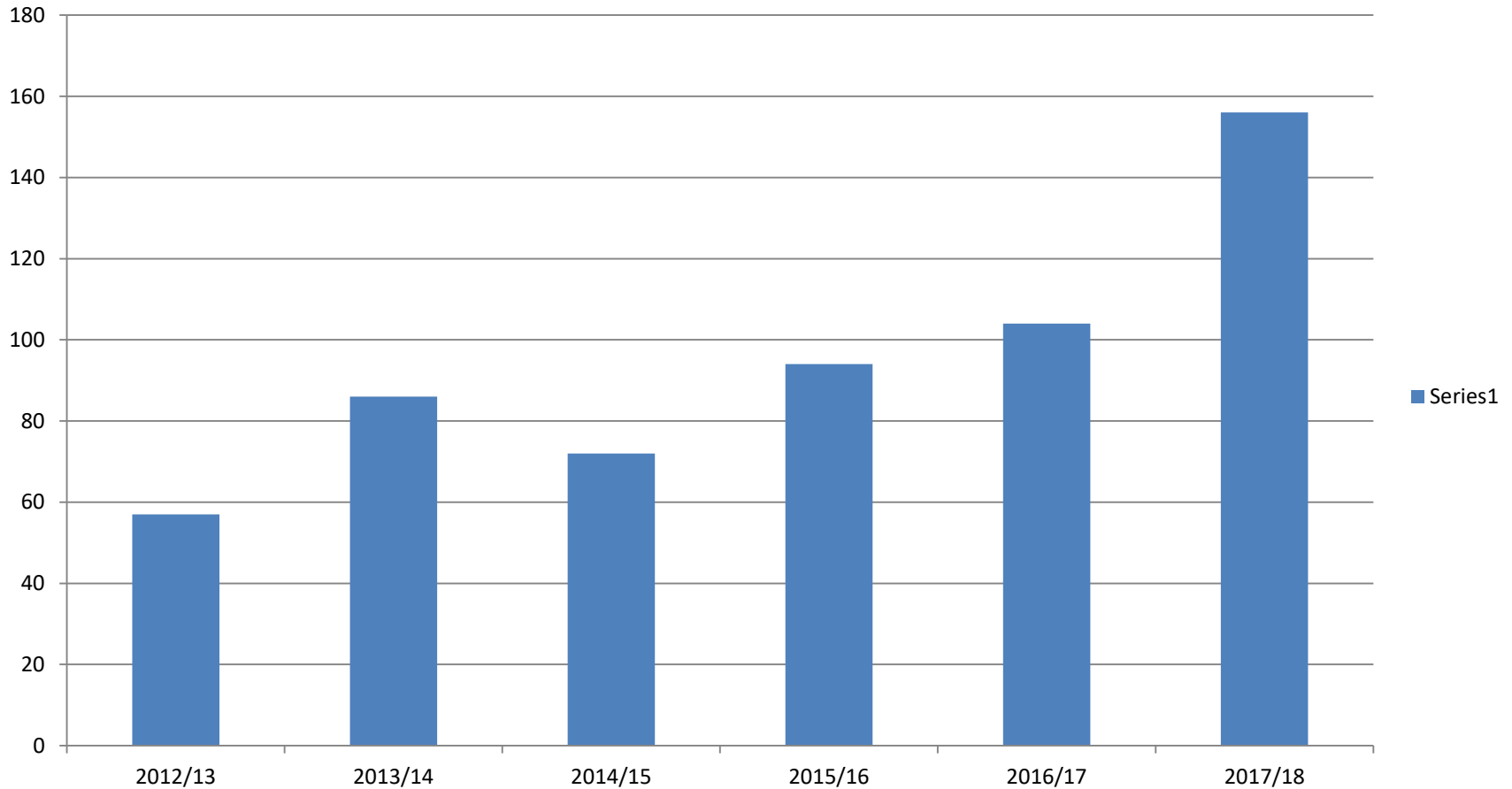

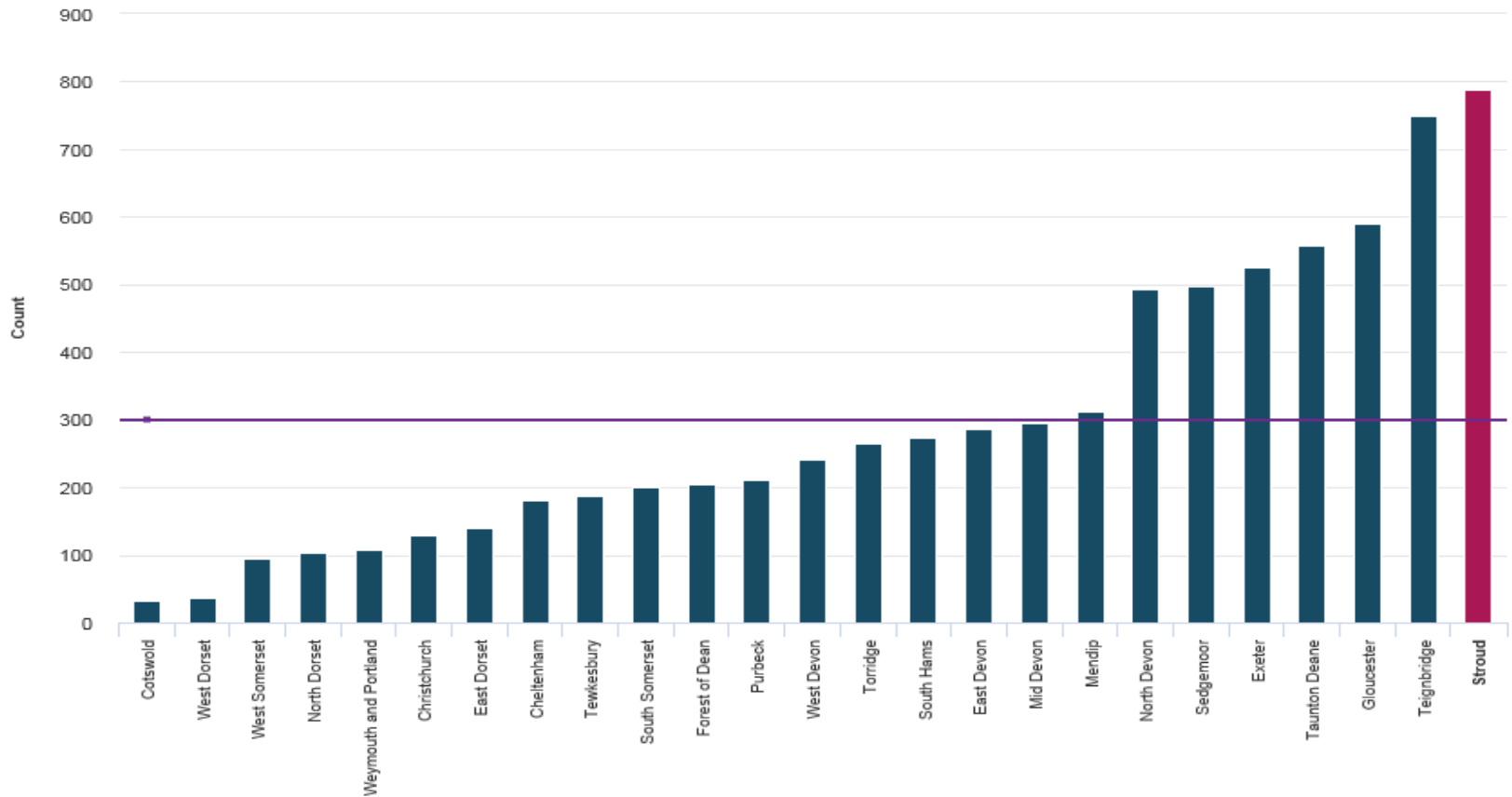

# Homeless Prevention.

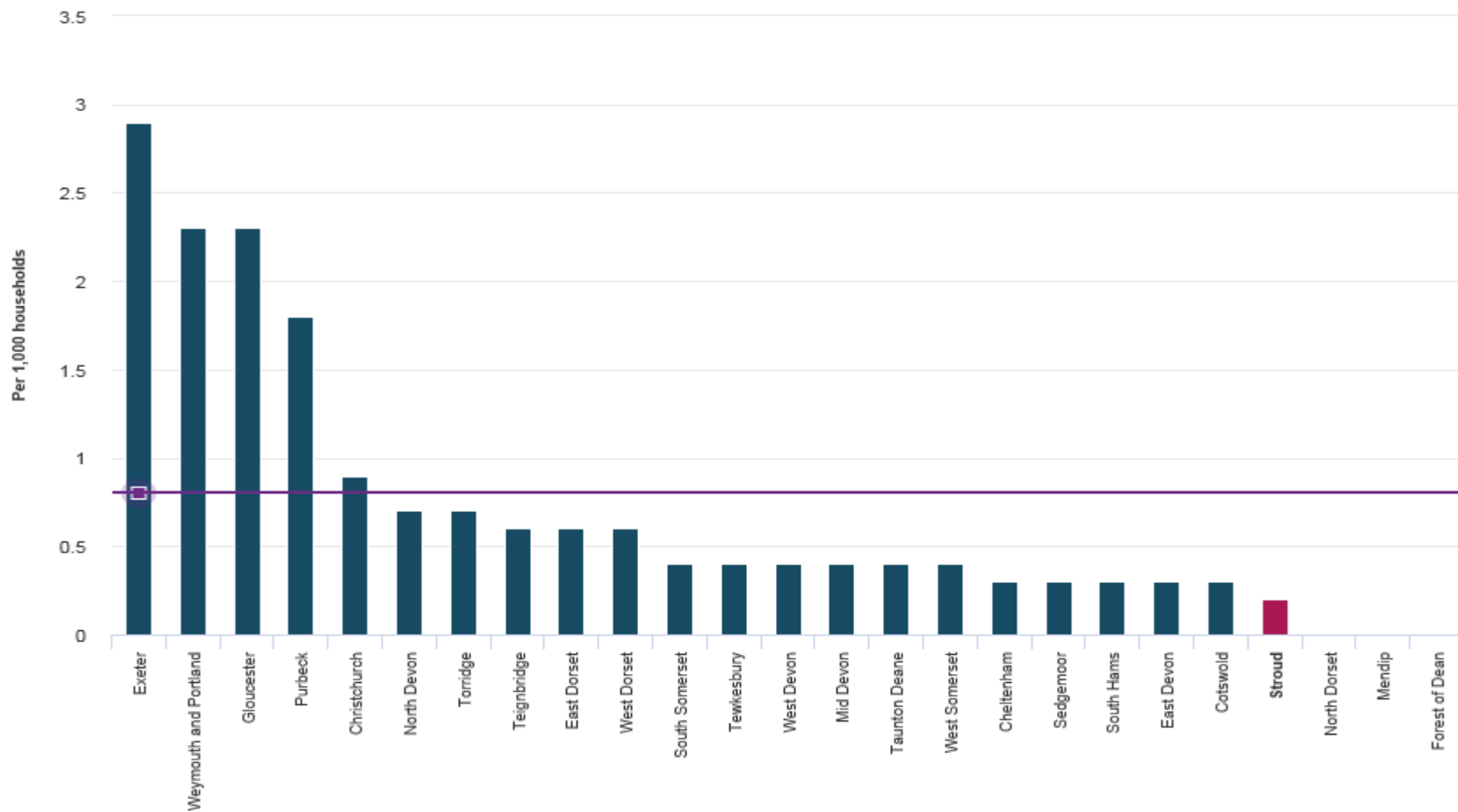
- Deposits and agency fees
- Mediation to prevent relationship breakdowns
- Sanctuary schemes
- Provision of rent guarantee insurance
- Payment of rent arrears in exceptional cases
- Referrals to floating support
- Financial advice
- Anything else that might work

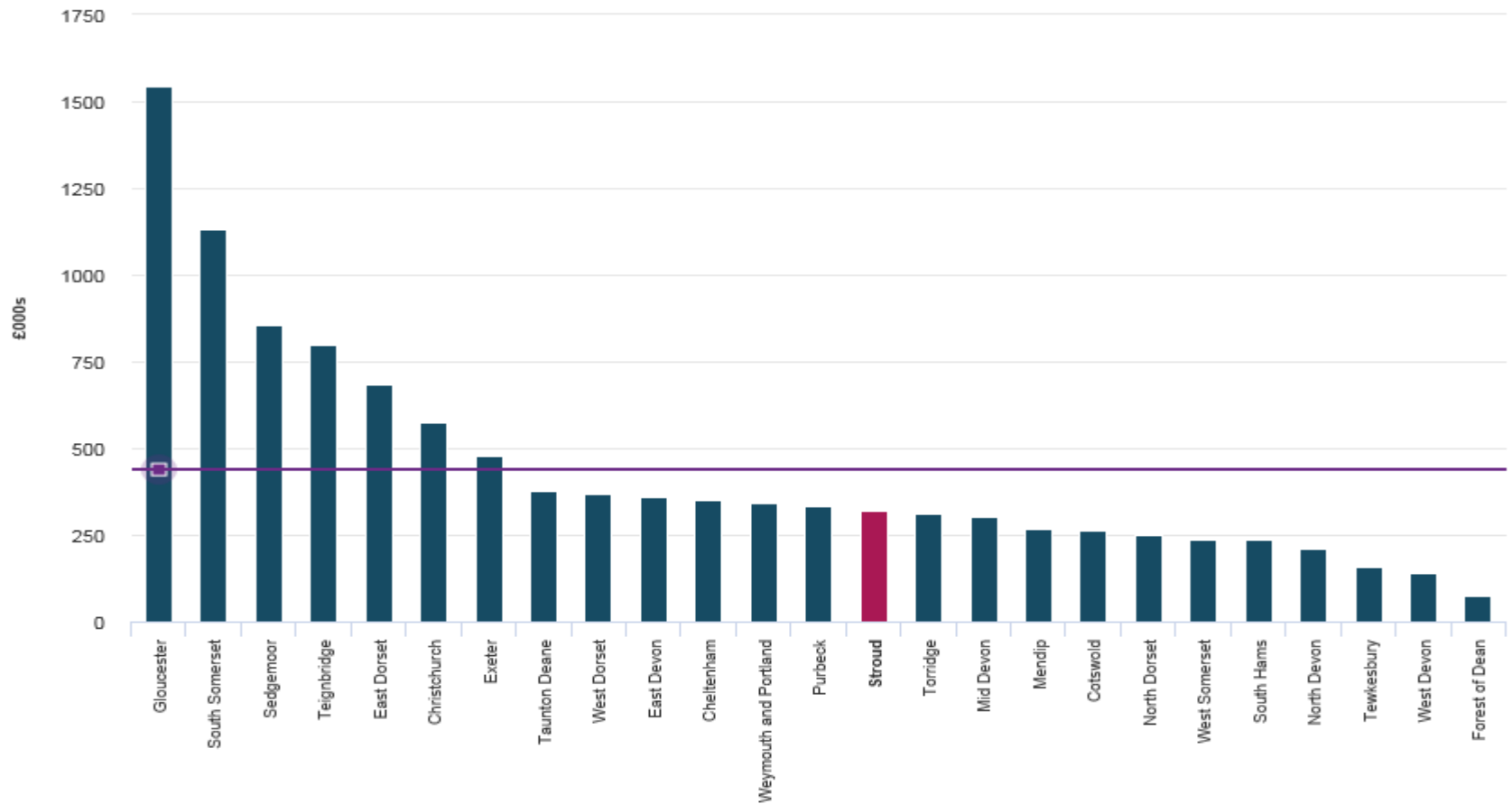
