1. Welcome, introductions, apologies.

Russell Warner (Chair) was unable to attend this meeting so Will Mansell (Vice Chair) chaired in his absence. The Vice Chair welcomed everyone and noted the apologies. The Vice Chair asked those in attendance to discuss one thing that is going well and one thing that isn't going well in their workplace/position with the person sitting next to them.

2. Update on draft Council Plan

Cllr Catherine Braun outlined the progress on the draft Council Plan since the previous LSP meeting in September. The previous LSP meeting provided an opportunity for LSP members to provide feedback on the draft Council Plan and discuss areas where SDC could make improvements. Cllr Braun outlined the improvements that were made following LSP feedback.

Public consultation began in October and closes Sunday 8th December at midnight. Cllr Braun explained the next steps for the Council Plan after the consultation finishes. To ensure the Council Plan is clear and easy to understand, a glossary will be included, and an easy-read version will be produced, as well as a one-page overview.

A question was asked about the language used in the Council Plan and whether it is understandable for 'ordinary people', as hard to understand wording can put people off from getting involved. It was noted that there are lots of different audiences for the Council plan and the actions within the Council Plan will explain more specifically what steps will be taken for each of the priorities, aims and objectives. The feedback on the language used within the Council will be taken into consideration going forwards. It was highlighted how the Gloucestershire Youth Climate Group translated the County Council's climate action plan into an easy-read document, so this is something the Council could consider in future.

A question was asked about the Temporary Accommodation Strategy, and it was noted that this can be viewed on the council's website.

Another question was asked about the Equality, Diversity, Inclusion & Equity Action Plan and where this can be found publicly. It was agreed that a link would be shared with the relevant LSP member following the meeting.

3. Community Emergency Planning

Rachel Seymour (Flood & Resilience Officer, GRCC) introduced herself to the LSP members.

The aim of GRCC is to create thriving, sustainable places for people to live and work. GRCC is a member of ACRE (Action for Communities in Rural England). GRCC aim to enable sustainable community development, and inspire, enable, and deliver community action.

Emergency planning can start at household level, such as grab bags, household emergency plans, ensuring householders have flood defences, and then develop to working with parish and town councils to develop community emergency plans. Emergency planning can be done for a wide range of situations. Knowing who is chair of the parish council, a builder, a tradesman, who has any first aid training, where the local defibrillator is located, is all essential to know how to respond to emergency situations.

Plans are created to help the community and emergency responders; plans should work in harmony with everyone and the emergency services. Emergency Planning doesn't replace the emergency services that are in the district. It gives the community the capacity to respond in the first instance effectively and puts in place a plan for the gap between calling the emergency services and waiting for them to arrive. Effective emergency planning can strengthen our communities.

Climate change as well as other external influences is affecting our weather patterns. Communities need to be able to respond to these to mitigate these changes. GRCC want the community to work together for the future generations, where people can stay and live in their area for as long as they want too.

Community Emergency Planning aligns with SDC's draft council plan priority 'Community Resilience & Wellbeing'. Resources for community climate action aim to empower communities, recommend environmentally friendly actions that can help combat climate change, and help the environment.

GRCC facilitate and coordinate the volunteer flood wardens. These are volunteers who voice the concerns of their community to implement changes in relation to flooding. They will be the voice of their communities, working with the Environment Agency, County Council, and anyone with a relationship to flooding, to ensure they are addressing any issues in that community.

A question was asked about how many flood wardens there are in the Stroud district. It was explained that there are none currently in the Stroud district yet, but GRCC are working with Gabrielle Webb to launch flood wardens in the Stroud district. Volunteers can be anyone over the age of 18, anyone interested in climate change, those effected by flooding in their community, or studying climate change related topics.

Another question was asked regarding how many flood wardens are appropriate when there are many smaller areas and villages in the district. Rachel noted that that there is a positive impact with a more connected community, and it can be very beneficial to have more flood wardens.

A further question was asked about whether people living at the bottom of hilly areas are being targeted to become flood wardens. Rachel explained that people from any area can be a flood warden and many volunteers might not necessarily be directly affected by flooding but can still help mitigate the problem. Rachel noted that flood wardens can report issues directly to the Gloucestershire County Council highways team.

4. Gloucestershire Fire & Rescue Emergency Response Arrangements

Lee Taylor (Stroud and Nailsworth Station Manager) introduced his presentation about Gloucestershire Fire & Rescue. Gloucestershire Fire and Rescue Service is made up of five wholetime stations, two in Cheltenham, two in Gloucester, and one in Stroud. SkillZONE is a community education facility that hosts school trips and school visits. Lee covered the specialist capabilities and different appliance specialisms and officer specialisms across the county.

There are four strands of things the team do: Prevention and protection, pre-planning, and emergency response. Lee and the team can conduct familiarisation visits, which include things like checking hydrants work, and completing ops planning forms and tactical forms. Other elements to pre-planning include business fire safety checks, predetermined attendance, recording temporary risks, road closures and event plans.

Gloucestershire Fire and Rescue Service undertake regular exercises, including testing new procedures and techniques, which are undertaken to ensure that all policies and procedures are effective and minimise casualties.

Gloucestershire Fire and Rescue Service sit under the Local Resilience Forum (LRF), a network for responders to communicate and work together for emergency planning and ensure effectively delivery of services. Command levels consist of three different stages. Strategic/Gold Commander, Tactical/Silver Commander, Operational/Bronze Commander.

An Oplink is a call that can be done in very short notice to get all the key responders onto a Teams call in an emergency. This enables the sharing of risks and hazards and makes it easy to communicate with each other.

Category 1 responders have a statutory duty of civil protection, and Category 2 responders have a limited supporting obligation to cooperate and share information.

Lee covered JESIP, which are joint models and principles that came out following the London bombings in 2007, and the 13/16 Arrangements which are intended to help fire and rescue services support each other and reduce the risk of being unable to handle an unexpected incident.

A question was asked about how district councillors or members of the public can report risks in the area. Lee noted that the business fire safety team can be contacted, who will go out and inspect the situation. Education plays a key part in these situations as lots of businesses/individuals don't realise that certain things are a fire risk.

Another question was asked about dealing with border issues and determining who responds to incidents close to borders. Lee explained that the closest appliance will respond regardless of border. For example, if there was a house fire in between two locations, both services would send out appliances with different resources to use in the situation.

A further question was asked about how often major incidents are tested Lee noted that there is a full major incident exercise every year, where they simulate a response, but there are also tabletop exercises throughout the year to ensure that officers and members of staff are trained.

A question was asked about whether organisations can request a familiarisation visit. Lee confirmed that this is possible, and crews can come out and offer safety advice.

There was some discussion about narrow roads in the district and access for vehicles. It was explained that there are restricted access vehicles (slimmer fire engines), and a 4x4 unit at Stroud, so they can ferry crews and equipment back and forth from a location. It was added that from a police perspective, the police will work with partners to ensure access and to help with moving cars that are parked on narrow roads.

A question was asked about why water companies are a Category 1 responder. It was explained that this is set by central government, but Severn Trent are very cooperative in in emergency planning situations.

Fire's links with the VCS sector was discussed and it was highlighted that there is a VCS "cell" where members of the VCS sector are involved in emergency planning.

5. Emergency Planning in Local Authorities

Gabrielle Webb (Emergency Planning Officer (Business Continuity)) introduced herself and gave an overview of where she sits within the Council. Gabrielle works with the LRF, and a lot of subgroups, including the risk subgroup, planning subgroup, and others.

Category 1 responders include all the blue light services, NHS trusts, port health authorities, and the environment agency. The MET office joined the list of Category 1 responders recently. Category 2 include electric and gas distributors, water and sewage companies, and telephone service providers. As a category 1 responder, local authorities have a duty to respond to emergencies and to provide temporary accommodation for those that become homeless through an incident or an emergency. The Council also takes a lead in setting up rest centres. SDC has a list of pre-identified rest centres with the facilities they offer. Stratford Park can house up to 800 people if required. In the event of an emergency, a coordination team will be set up within the council offices to help coordinate the rest centre and emergency. In the event of an emergency, SDC will adopt the Command-and-Control structure. There are 14 silver tactical officers. There is always a silver or gold officer on call each week. Bronze team is the works team.

A question was asked about who determines when an incident turns into an emergency. It was explained that any organisation can arrange an op link call and declare an emergency. The government will cover financial losses or provide funding if necessary. Lots of different partners may need to be involved in the emergency for intelligence gathering.

Another question was asked about when the last rest centre was set up. Storm Eunice was the last time one was set up, but it didn't need to be open for long.

A further question was asked about the systems that are in place to communicate if Wi-Fi/signal goes down. It was noted that councils have RAYNET, the UK's national voluntary communications service provided for the community by licensed radio amateurs.

There was some discussion about communications as it was noted that communication was not great during COVID. The council review every incident for learnings and communication is always the first thing that is discussed when it comes to how SDC can improve. It was discussed how the LSP can support with communicating some of the information that is covered during the LSP meetings.

Social media was also discussed, including how it can be used in an emergency and in relation to mis- and dis-information. Rachel Seymour mentioned that GRCC are working on a piece of work about this, including evaluating previous situations and how misinformation can be prevented in emergency planning. James Hutchins mentioned that the Police communicate very carefully on social media, and a robust communication strategy is essential. It was also noted that people are choosing to film incidents on their phone, rather than calling the emergency service.

6. Recruitment of Vice Chair

Russell Warner's term as Chair will end in June 2025 and Will Mansell will take over the Chair position. This means there is an opportunity for someone to become the new Vice Chair. The next Vice Chair should come from the public sector as per the Terms of Reference. If anyone is interested in this role, please let the LSP coordinator know.

7. Future LSP meeting themes

The Vice Chair asked the group to consider themes for future LSP meetings and send any suggestions through to the LSP Coordinator.

8. Partners' updates

Steve Olczak, Partnership Manager, Department of Work and Pensions:

The Stroud Job Centre is back open. With regards to pension credit, please remind people of State Pension age (66+) who are not receiving certain benefits* that they should check their eligibility and apply for Pension Credit, as they could qualify for Winter Fuel Payment* and other support like help with housing costs, help with Council Tax and a free TV licence for those aged 75 and over. There is also a new Veteran's Travel Card in collaboration with Gloucestershire County Council, which can be issued at any Gloucestershire Job Centre. The card enables the individual to have 50 single bus journeys which cover pretty much all the main providers as listed below, Should the Veteran use the 50 single journeys on card, they can go back to the Jobcentre to request another.

The bus travel card can be used 24 hours a day. Just hold the bus travel card against the card reader when you board a bus. Bus travel is not possible across county boundaries. Please contact Steve Olczak for further information.

These events will be happening in April at St Lawrence Church. 15 sessions are booked with Schools, and evening sessions will be available for local adults and students. There are lots of partners involved in this project, so please look out for it.

Ian Hunter, Chamber of Trade and Commerce, Stroud & District:

Chamber of Trade and Commerce have hosted a range of projects to attract more tourism to the area. This is the first year that they are coordinating the Goodwill festival. They will continue to promote the Stroud district in the future.

Georgia Spooner, Climate Engagement and Advocacy Officer, Stroud District Council: The Climate Change and Sustainability team are refreshing the 2030 Strategy, which will be called the Climate and Nature Strategy. The Chair and Vice Chair will be attending an LSP meeting next year to hear ideas and comments. There is also a new company called 'Furbnow' that has been launched to help homes who have the money to retrofit their homes to make sure they are well insulated.

Anna Bonallack, CEO, Creative Sustainability:

The Creative Sustainability Hub on John Street will be educating people on the practical measures people can take to support a more sustainable future. Community programmes including the Stroud Library of Things (SLOTH) are taking shape. Bike repairs and refurbishments are also going well. Creative Sustainability are starting to look at supporting people to fix their small devices, as well as offering specialist and expert advice and running workshops regarding home insulation and similar things of nature.
